ETHICS

1. Limit outside income earned by state legislators up to 25 percent, while enacting a salary increase and eliminating stipends.	Support

8. Grant New Yorkers on parole the ability to vote automatically, without the need to obtain a Certificate of Good Conduct or Relief.	Support
9. Consolidate the state and federal primary to the third week in June, while ensuring that the legislative session ends at least two weeks prior.	Support
10. Institute Instant Runoff Voting (IRV) for primary elections in citywide election in New York City, effectively eliminating the need for a separate runoff election.	Support
11. Reform the special election process, utilizing a nonpartisan special election for state legislative seats, eliminating delays for filling vacancies, and increasing voter choice.	Support
12. Allow primary winners to decline party nominations, ending use of judicial appointments to lure candidates off the ballot.	Support
13. Restructure the state Board of Elections and change election administration by amending the constitution to abolish the strict two-party division of governance and operation and putting in place professional, nonpartisan administration.	Support

ADDITIONAL STATE GOVERNMENT ISSUES

Reform the governance structure of the Port Authority of New York and New Jersey to have the Executive Director appointed directly by the Board of Commissioners, rotate the position of Chair of the Board between representatives of NY and NJ, place tighter rules on the Board, and extend the open meetings law to the Port Authority. TOP FIVE 2016 CAMPAIGN PROMISES OR GOALS

1. Complete restructuring and overhaul of the electoral process and election law to include proportional representation, instant run off voting, consolidation of primaries, making election work unionized civil service jobs, easing restrictions on ballot access for alternative parties, eliminating all types of electronic voting and instituting a full paper ballot system.

2. Reject Fair Elections and Institute a publicly funded clean money/ clean elections campaign funding system on the model of states like Maine and Arizona.

3. Ending state funding of charter schools, removing them from the state public school system, and providing complete funding to our public schools; supporting and encouraging teacher unions; end to common core.

4. Attaining the goal of 100% renewable green energy use by 2050; end to the use of coal, oil, nuclear energy, and a total ban on methane gas production through hydraulic fracturing; ban on transportation of fracking materials and nuclear waste through NY State. Shut down all nuclear power plants in NY. Working with communities, unions, environmental groups and legislators in drafting a comprehensive “just transition” plan to retrain and employ former fossil fuel and nuclear workers into green energy jobs.

5. Repeal of the Urstadt Law. Strengthening of rent protection law for all tenants, adding these same protections for small businesses.

III. ETHICAL REPRESENTATION OF CONSTITUENTS

Citizens Union believes that all New Yorkers deserve to be represented by officials who work for the public interest and honor public trust. With the corruption conviction of recent legislative leaders, we seek to endorse a candidate who will demonstrate that he/she will honor the full commitment of the oath of office, and to always represent the public interest above all else.

Please tell us how you would conduct the political affairs of this office in an upright manner, and restore the public trust in your district.

I would encourage communities to form people's assemblies as a counter to appointed, unelected community boards. I would hold regularly scheduled meetings throughout the district at times and days announced well in advance and held at convenient times and locations for maximum participation by the community. I'd make it easier for constituents to contact and speak directly with me. No decision will be made without input and participation of the community. I'll stand with the people, not business and industry.
